Additional Event Regulations

It is the responsibility of exhibitors to ensure the dog entered is eligible for the entered event. Eligibility for participation in the event is defined by the AKC and can be found on the American Kennel Club website: www.akc.org. No refund of entry fees will be made if the dog runs despite being ineligible.

We ask the cooperation of exhibitors in helping keep the event location as clean as possible in order for us to retain the use of this facility for future events.

No refund for duplicate entries. Every effort will be made to find all duplicate entries, but if an entry has been processed, no refund will be made.

Entries must be received by the published closing date to be acceptable, and may not be changed, substituted, corrected, signed, or cancelled after that time, except as provided in AKC Rules, Regulations, Policies, and Guidelines. Incomplete, unsigned, conditionals, telephone, telegraph, or entries received without fees are not acceptable. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries must be on the enclosed blank or a reasonable facsimile thereof. Entries must include the Agreement on the back of the form.

RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will assess a collection fee of \$25.00 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put upon a cash-only basis.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian, judge or tester or barred from competition by the Show Committee. If, because of riots, civil disturbance, or other acts beyond control of the Club, it is impossible to open or complete the show, no refund of entry will be made.

The club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness, or other causes, and no one shall have any claim or recourse against the club or any official thereof.

Dogs must be ready for their run. Judges have the authority to refuse to judge any dog that does not appear within five minutes of being called for its run. The Event-giving Club and Event Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Exhibitors must be governed by any rules or regulations of civil authority, building and parking restrictions. Vehicles parked contrary to regulation will be subject to towing at the owner's expense.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and safe the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.
