Santa Rosa Valley Park Herding Events -- Disaster and Emergency Plan for People and Dogs

FIRE: Dial 911. All dogs should be crated or leashed securely and people must make sure that they, their dogs, and their vehicles are out of driveways that fire/emergency vehicles would use for approach to the site of the fire.

FOREST FIRE: All people and their secured dogs should immediately follow fire/emergency personnel evacuation directions and orders.

THUNDERSTORMS WITH LIGHTNING: All people and dogs should be in the security of their vehicles until the storm has passed.

EARTHQUAKES: Remain on the site with dogs secured. Use arenas for emergency animal housing if necessary. Wait for instructions via radio.

FOR ALL INJURIES: First Aid Kit is at Trial Secretary's area.

INJURY OR HEALTH PROBLEM WITH A PERSON: If injury is immediately life-threatening - Dial 911 immediately for the emergency response team for the area.

For serious but not immediately life-threatening injury or illness - Dial 805-389-5800 to alert **St John's Pleasant Valley Hospital**. Proceed with victim to the hospital.
